PROGRAM OBJECTIVES

Quality of Care is very important in Diabetes Care. Diabetes is the sixth most expensive condition nationally. An estimated 7.2 percent of New Jersey's population 18 years of age and over or 473,000 people have been diagnosed with diabetes. An additional 189,000 people are believed to have diabetes but have not been diagnosed.

Complications related to the disease affecting people with diabetes are numerous. Heart disease is the leading cause of diabetes related death. Stroke, blindness related to diabetic retinopathy, dialysis treatment due to end stage renal disease and non-traumatic lower limb amputations are some of the related complications.

The Summit provides strategies for improving and achieving quality of diabetes care in a variety of practice settings. It will also demonstrate how electronic medical record systems can be used to enhance the quality of care in a clinical setting and to offer practical guidance on implementing a system.




